



Application for a Certificate of Authorization Tree Cutting

Eligibility Requirements

Justification for the application

A certificate of authorization is required to cut down any tree having a diameter of 10 cm (4") or more measured at 15 cm (6") from the ground level.

The applicant is asked to place a string around the trunk of the tree that is the object of the current application for tree cutting so that it may be clearly identified on site.

Processing of the application

Certificates of Authorization for tree felling are issued free of charge and, where applicable, are sent to the applicant by email within **twenty (20) working days** of receipt of the application form.

It is important to specify the reason justifying the request and to fill in all required fields on the application form to avoid delays in processing. Once duly completed and signed, please submit the application form to the Public Works Department in either of the following ways:

Please note that where the tree cutting certificate is requested for the purpose of accommodating a new construction, an expansion project or the installation of a swimming pool or a spa, it must be processed together with the application for the required building permit. In such a case, the applicant is asked to submit his/her request to the Urban Planning Department (Kirkland Town Hall, 17200 Hymus Boulevard, Kirkland H9J 3Y8 – urbanisme@ville.kirkland.qc.ca 514 694-4100 x3137).

Replacement of a felled tree

Within **90 days** of felling, **every tree that was cut down in the front yard of a private property, as well as every ash tree felled on private property**, must be replaced with a tree that is at least 1.5 metre in height, other than an ash tree or a prohibited species such as poplars, willow trees, catalpas and silver maples.

The Town offers replacement trees for a minimal fee.

Particular provisions applicable to ash trees

Within the context of the fight against the spread of the emerald ash borer (AEB), it is prohibited to plant, grow or otherwise cultivate an ash tree within the territory of the municipality. Certain restrictions also apply to the disposal of ash wood. Please visit the Town's website at www.ville.kirkland.qc.ca for more information.




