BY-LAW AMENDING ZONING BY-LAW NO. 90-58 IN ORDER TO ADJUST THE FINE APPLICABLE FOR THE FELLING OF TREES IN CONTRAVENTION TO THE BY-LAW

CONSIDERING	that in accordance with section 113 of the <i>Act Respecting Land use Planning and Development</i> , (CQLR c. A-19.1), the Town of Kirkland may regulate the felling of trees to ensure protection of the forest cover and promote sustainable development of private forest;
CONSIDERING	that the Town of Kirkland must ensure concordance between its municipal by-laws and section 233.1 of the <i>Act Respecting Land use Planning and Development</i> , (CQLR, c. A-19.1);
CONSIDERING	that notice of motion of this by-law was given and that adoption of the draft was done at the regular sitting of the municipal Council held on June 7, 2021;
CONSIDERING	that in accordance with section 356 of the <i>Cities and Towns Act</i> (CQLR, c. C-19), copies of the draft by-law were made available to the public;
CONSIDERING	that the present by-law contains no provision making it a by-law subject to

- CONSIDERING that the preamble forms an integral part of this by-law;

THE MUNICIPAL COUNCIL DECREES AS FOLLOWS:

SECTION 1

Section 1.7 of *Zoning By-Law No. 90-58* is amended by adding the following paragraph, after paragraph a):

"a.1) Notwithstanding section 1.7 a), anyone who fells a tree in contravention of a provision of this by-law is liable to a minimum fine of **FIVE HUNDRED DOLLARS** (\$500) plus,

(1) for felling trees on less than one hectare of land, an amount varying from **ONE HUNDRED DOLLARS** (\$100) to **TWO HUNDRED DOLLARS** (\$200) per tree illegally felled, up to a total of **FIVE THOUSAND DOLLARS** (\$5,000); or

(2) for felling trees on one or more hectares of land, a fine varying from **FIVE THOUSAND DOLLARS** (\$5,000) to **FIFTEEN THOUSAND DOLLARS** (\$15,000) per hectare deforested, in addition to an amount determined in accordance with subparagraph 1 for each fraction of a hectare.

These amounts are doubled for a second or subsequent offence."

SECTION 2

The present by-law comes into force according to law.
